- (b) have an original or certified copy of valid Good standing Tax Certificate;
- (c) have an original or certified copy of valid Good standing Social Security certificate;
- (d) have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998
- (e) have or sign written undertaking as contemplated in section 138(2) of the Labour Act, 2007
- (f) submit a signed Bid Securing Declaration;
- (g) Sign and/initial the whole document

1. Bid Securing Declaration:

Bidders are required to subscribe to a Bid Securing Declaration for this procurement process. The bidder shall furnish as part of its quotation, a Bid Securing Declaration as per the format contained in Schedule 1 of this document

2. Prices:

Prices shall be quoted in Namibian dollars. Prices quoted shall be firm and fixed during validity period of quotation and for execution of contract.

3. The Contract:

The letter of Acceptance/Purchaser Order as the case may be together with this Informal Quotation form shall constitute the contract between the Public Entity and the Supplier.

4. Purchase order:

A supplier to whom a purchase order is issued must confirm the purchase order within three days of receipt of the purchase order and;
(a) may not change or alter the terms of the purchase order; and

- (b) Must undertake to deliver the goods or services on the date set in the purchase order for delivery of the goods or services.
- (c) The Purchase Order shall be valid for 21 days only and will be cancelled thereafter.

5. General Conditions of Contract:

6. Warranty:
